# **Course Purpose**

This course presents a survey of the Christian Church as it was transplanted and transformed on American soil. The history of revivalism and the growth of evangelicalism will receive particular attention in the context of American frontier expansion. We will also focus on the social upheaval of the Civil War, the waning influence of confessional Christianity and the social tensions of the  $20^{th}$  Century and its impact on the mission of the Church.

# **Course Objectives**

- 1. The student will be able to name and discuss major events in the course of the history of Christianity in America.
- 2. The student will be able to name and explain the contribution of many of the instrumental people who shaped the history of Christianity in America.
- 3. The student will be able to describe the development of Christian thought and doctrine as a result of historical developments and key individuals.
- 4. The student will be able to examine and relate the lessons of history to current developments.
- 5. The student will be able to identify and become familiar with various views different segments of the church have held concerning culture, origins, racism, segregation, marriage, and the consequences of such views in a multicultural, pluralistic society.

## \*Course Requirements

- 4. Write two Book Reviews (3-4 pages exclusive of title page and endnotes) examining the books listed below. These essays should be submitted as hard copies at the beginning of each class session. The following should be included in your Book Review: Title: "Church History in America, Book Review #." Each review needs to address the author, the audience, the historiographical context, the argument(s), the evidence, and how convincing the book was as a whole.

- 5. Complete the Historiographical Essay Project. This is comprised of three parts:
  - a) A review essay (7-9 pages exclusive of footnotes, bibliography, title page, and table of contents) on any one of the books listed in the Bibliography section below. You may write on another book with the professor's prior approval. This essay should address the author, the audience, the surrounding literature, the argument(s), the evidence and how convincing the book was as a whole. All papers must be 12-point Times New Roman font and formatted in accordance with Turabian/Chicago standards. This paper needs to be provided as a hard copy to me on the due date and include the following title on your submission: "Church History in America, Historiographical Essay."
  - b) An oral presentation of your chosen book.
  - c) A summary/outline of your chosen book addressing the historical context, the argument and key themes, as well as the evidence employed by the author. This summary will be distributed to your classmates and it should be typed and no more than two pages single spaced.
- 6. A mid-term exam which will consist of short answer, multiple choice, and short essay questions.
